## Registration and Tuition Policies

### School Year

  - Spring Break: 04/10~04/14

### Registration and Enrollment

- Each applicant will be accepted upon submission of following items:
  - a signed Registration Form
  - annual registration fee (\$25) plus half of the yearly tuition
- When enrolling you are automatically enrolled through each academic year.

**Admission to the program is subject to a contractual commitment for the entire year.**

### Tuition and Cancellation Terms

- Registration fee and deposit are due at the time of enrollment. Both registration fee and tuition deposit are **nonrefundable**.
- The remaining tuition is due on the first class of each school year regardless of absence due to illness, vacations, or any other circumstances. Late fees are incurred at \$10 per week past due date.
- Tuition will be prorated for students joining the class during school year.
- There will be a \$25 charge for each returned check.
- There are no refunds, credits, extensions, or transfers of any tuition after completion of the first week of the class.
- There is a ten-minute grace period after class for pickups. Families leaving children at the center for more than ten minutes after class will be charged \$10 for every 10 minutes beyond the grace period.
