Tuition and Cancellation Policy

- Total tuition (The camp tuition plus a \$25 **non-refundable** registration fee) is due at the time of registration regardless of absence due to illness, vacations, or any other circumstances.
- **10%** discount for all current students.
- There will be no refunds, extensions, or transfers of any tuition **after 6/11/18** unless the camp is cancelled due to low enrollment. The camp tuition minus **\$30** administration fee is refundable **by 5/1/18**. Half the tuition minus **\$30** administration fee is refundable between **5/2/18-6/10/18**.
- There will be a \$25 charge for each returned check.
- There is a **5** minute grace period after camp pickups. Families leaving children at the center for more than **5** minutes after camp will be charged **\$10** for every **10 minutes** beyond the grace period.
