### Registration and Enrollment

- Each applicant will be accepted upon submission of the following items:
  - a signed Registration Form
  - tuition (plus registration fee new students)
- When enrolling you are automatically enrolled through each season.

**Admission to the program is subject to a contractual commitment for the entire season.**

### Tuition and Cancellation Terms

- Registration fee and tuition are due at the time of enrollment. Both registration fee and tuition are **nonrefundable**.
- Tuition is not to be pro-rated, regardless of absence due to illness, vacations, or any other circumstances. Late fees are incurred at \$10 per week past due date.
- There will be a **\$30** charge for each returned check.
- There are no refunds, credits, extensions, or transfers of any tuition after completion of the first week of the class.
- There is a five-minute grace period after class for pickups. Families leaving children at the studio for more than ten minutes after class will be charged \$10 for every 10 minutes beyond the grace period.
