Registration and Enrollment

- Each applicant will be accepted upon submission of the following items:
 - a signed Registration Form
 - tuition (plus registration fee if applicable)
- When enrolling you are automatically enrolled through the **quarter (for PW I & Sat. Club)** or **academic year (for PW II)**.

Tuition and Cancellation Terms

- Registration fee and tuition deposit are due at the time of enrollment. Both registration fee and tuition deposit are **nonrefundable**.
- Tuition is not to be pro-rated, and there is no make-up class, regardless of absence due to illness, vacations, or any other circumstances. Late fees are incurred at **\$10** per week past due date.
- There will be a **\$35** charge for each returned check.
- There are no refunds, credits, extensions, or transfers of any tuition after completion of the first week of the class.

There is a **five-minute grace period** after class for pickups. Families leaving children at the studio for more than ten minutes after class will be charged **\$10 for every 10 minutes beyond the grace period**.
