Total tuition (plus a \$25 registration fee if applicable) is due at the time of registration regardless of absence due to illness, vacations, or any other circumstances.

- **The camp tuition minus \$25 administration fee is refundable before 04/14/25.**

Half of the total camp tuition is refundable 04/14/25 ~ 05/05/25.

There will be **no refunds**, extensions, or transfers of any tuition **after 05/05/25** unless the camp is cancelled.

- There will be a **\$35 charge for each returned check.**
- There is a **10-minute grace period** after camp pickups. Families leaving children at the center for more than **10** minutes after camp will be charged **\$10** for every **10 minutes** beyond the grace period.
